The Arc Westchester and CCSD Department of Special Education continue their partnership for a second year to assist district staff, transition-aged students, and their families in transition planning.






## Transition Planning

Transition planning is a process to help students with an Individualized Education Program (IEP) decide what they want to do after high school & how to get there.

The purpose is to help teens prepare to be independent young adults.



#### **Transition Planning Cont.**

Planning for the transition from high school to young adulthood is different for each student.

- Student's experience, interests, and goals
- Level of Independence
- Stamina
- Medical and/or Behavioral Support Needs
- Funding Stream
- Transportation

- Does the student meet the eligibility criteria for the program/service?
  - Stamina
  - Ratios
  - Independence
  - communication
- What are the program/service expectations?
- Do organizations in our area have openings?
- What is the application process?
- What can the student do now to help them build skills needed for their future?
